NOTICE OF INTENT TO ESTABLISH RATES

Comes now, Town of Edwards Water System, by and through its
Mayor, hereinafter referred to as Petitioner, and pursuant to Section 77-3-37 of the
Mississippi Code of 1972, gives notice of its intent to set rates and tariffs for the
rendition of water service to its customers and would show as follows, to -wit:
Petitioner is a public utility as defined in Section 77-3-3 (d) of the Mississippi
Code of 1972, as amended, and is engaged in the business of providing water
service to and for the public for compensation in Hinds County, Mississippi, having its
principal place of business at 310 Front Street. Petitioner's mailing address is
P.O. Box 215 Edwards, MS 39066. Petitioner's telephone number is 601-852-5461.

II.

Petitioner is the holder of a Certificate of Public Convenience and Necessity

authorizing its operations in a specified area of Hinds County, Mississippi, and is prepared to render service in accordance with service rules and regulations and in accordance with a schedule of rates and charges, both of which shall be a part of the tariff for which it seeks approval through an order of this Commission.

III.

Petitioner proposes to implement initial rates, effective thirty (30) days from the date of filing this Notice, for services rendered on and after such date.

IV.

Petitioner would show that it has carefully reviewed its operating methods and has taken all feasible steps to establish normal monthly overhead and operating costs and believes that it will operate and maintain its system in an economical manner. Petitioner would show that the proposed rates and tariffs noticed herein are required and necessary in order to meet customer requirements and to provide an adequate return to the Petitioner.

V.

Petitioner proposes herewith a tabulation of rates applying to its certificated area in Edwards, Hinds County, Mississippi, and respectfully requests that the proposed initial rates be received and approved in accordance with all applicable provisions of law and all Commission regulations.






