MOTION TO INTERVENE

COMES NOW Scenic Hill Solar, LLC ("Scenic Hill Solar") pursuant to RP 6.121 of the Mississippi Public Service Commission's ("Commission") Public Utilities Rules of Practice and Procedure ("Rules") and hereby files this Motion to Intervene in the above-styled proceeding. In support thereof, Scenic Hill Solar submits the following:

1. Scenic Hill Solar is an Arkansas limited liability company based in Little Rock that is focused on the commercial solar market. It has developed a dozen solar facilities in Arkansas and continues to be a very active participant in Arkansas Public Service Commission ("PSC") Docket No. 16-027-R, regarding the establishment of net-metering rules. Scenic Hill Solar's familiarity with the Arkansas rules will provide a valuable perspective in the present docket.

2. Scenic Hill Solar has developed and is developing solar facilities for municipalities, school districts, private industry, hospitals, counties, and non-profits. To date, these facilities have primarily been in the one megawatt ("MW") range, while the largest is 6.5 MW. Most of these facilities are in the service territory of Entergy Arkansas, LLC ("EAL"), and therefore, Scenic Hill Solar is very familiar with EAL's interconnection processes.

3. Scenic Hill Solar intends to participate in the present docket to assure that Mississippi develops fair, efficient, and comprehensive net-metering and interconnection rules.

4. Scenic Hill Solar has a substantial interest in the Mississippi PSC's net metering and interconnection rules because it is considering expanding operations into Mississippi. The rules adopted in this proceeding will inform that decision.




