NOTICE OF THAXTON HILLS UTILITIES, LLC OF INTENT TO SET INITIAL RATES FOR SEWAGE DISPOSAL SERVICE IN ITS CERTIFICATED AREA IN PONTOTOC COUNTY, MISSISSIPPI (THAXTON HILLS SUBDIVISION)

ORDER APPROVING INITIAL RATES

THIS DAY, there came on for consideration before the Mississippi Public Service Commission ("the Commission"), the Notice of Intent filing ("NOI") submitted by Thaxton Hills Utilities, LLC ("Thaxton Hills") to establish initial rates, charges, and a Tariff applicable to its sewage disposal service provided within its Certificated Area located in Pontotoc County, Mississippi. Based upon the NOI filing by Thaxton Hills, the entire record of this matter and upon the recommendation of the Public Utilities Staff ("the Staff"), the Commission hereby finds, as follows:

INTRODUCTION AND PROCEDURAL HISTORY

On December 22, 2020, Thaxton Hills filed its NOI to establish initial rates, charges and a Tariff applicable to its rendition of a sewage disposal service within its Certificated Area, as granted to it by the Commission in Docket 2020-UA-014, which Certificated Area is located within Pontotoc County, Mississippi.

On December 23, 2020, the Commission issued a Suspension Order and requested that the Staff conduct a full investigation of the lawfulness of the NOI presented by Thaxton Hills. The Staff has completed its investigation of the NOI filed by Thaxton Hills, after receiving sufficient

data and information provided to it by Thaxton Hills in response to data requests sent during the discovery phase of this proceeding.

JURISDICTION/NOTICE

Thaxton Hills operates as a public utility, as defined in Miss. Code Ann. §77-3-3(d)(iv), pursuant to its Commission-issued Initial Certificate of Public Convenience and Necessity ("CPCN") for the provision of a sewage disposal service within Pontotoc County, Mississippi. This CPCN covers an area also known as *Thaxton Hills Subdivision*, consisting of around ninety-two (92) lots.

The Commission has jurisdiction over Thaxton Hills and the subject matter in this proceeding. Publication of the NOI filing submitted by Thaxton Hills occurred on January 21, 2021, in *The Clarion-Ledger* & on January 20, 2021, in *The Pontotoc Progress*. In addition to these publications, all affected customers located within the Certificated Area held by Thaxton Hills were provided notice of the NOI filing by Thaxton Hills on January 24, 2021. The Commission incorporates herein, by reference, all publications and notice to customers, which documents are on file in the record hereof. The Commission finds that due and proper notice of this filing has been provided pursuant to applicable law. No objections or requests to intervene have been filed in this Docket.

FINDINGS

After its thorough investigation of the NOI filing, as submitted by Thaxton Hills, the Staff recommends to the Commission approval of the NOI establishing initial rates, charges, and a Tariff for the rendition of a sewage disposal service applicable to the *Thaxton Hills Subdivision*.

The Commission finds that the NOI, along with the proposed Tariff filed by Thaxton Hills, contains initial sewer rates, which are deemed to be fair, just and reasonable. Approval of these

initial sewer rates should enable Thaxton Hills to meet its reasonable and necessary expenses and be financially able to furnish reasonably adequate sewer service to the residents located within *Thaxton Hills Subdivision*.

The Commission hereby approves the NOI, including the proposed Tariff filed by Thaxton Hills and marked hereto as Exhibit "A". This approved Tariff reflects the schedule of initial monthly rates and charges, along with the terms and conditions for the rendition of sewer service, to the public for compensation, within the Certificated Area held by Thaxton Hills, located in Pontotoc County, Mississippi.

IT IS THEREFORE, ORDERED, that the NOI, submitted by Thaxton Hills, is approved, along with the attached Tariff, marked as Exhibit "A" hereto, which Tariff reflects the schedule of approved initial rates, terms, and conditions for the rendition of sewer service, to the public for compensation, within the Certificated Area served by Thaxton Hills and located within Pontotoc County, Mississippi.

This Order shall be deemed issued on the date it is served upon the parties herein by the Executive Secretary of the Commission who shall note the service date in the file of this Docket.

In the event a utility representative is dispatched to disconnect service and the customer chooses to pay any arrearage at such time, in lieu of the disconnection and resulting reconnection fee, there shall be levied a \$37.50 charge at such time, in addition to the arrearage.

I. Availability

II. Cash Deposit

Thaxton Hills does not intend to require a deposit from its customers.

III. Tap/Connection Fee

A service connection fee as shown by rates and charges herein will be required of each customer. Payment of this fee will be in advance of any installation or construction work by the Utility, and will include the cost of making actual connection and extending the service line to the customer's property line at a mutually agreeable point. This fee will be collected only once for a given service location.

IV. Late Fee

All bills are due and payable by the 1st of the month which is subsequent to receipt. Bills not paid by the 10th of said month will be assessed a \$5.00 late charge.

VI. Reconnection Fee

A fee for reconnection of sewer service as shown by rates and charges herein will be applicable in case the sewer is shut off for the reason of non-payment.

A. Application of Policy

The Service Extension Policy of Thaxton Hills Utilities, LLC shall apply in those instances where the service in question is not readily available from a point on the existing system without a system extension and/or where the quantities are beyond the ability of the system to service at the point where the service is requested.

B. Application for Service

In such instances, the prospective customer shall clearly state the type of sewer service desired and shall clearly define the point at which service is desired in a written application for service.

C. Estimate of Cost and Availability of Service

Thaxton Hills Utilities, LLC will estimate or cause to be estimated the cost of providing the service requested at the point indicated in order to evaluate properly the factors influencing the extension of such service.

D. <u>Contribution-In-Aid-Of-Construction</u>

If a Contribution-In-Aid-Of-Construction is made by a prospective customer, the contribution will be considered as a non-refundable cash requirement of the Utility, and the Utility will own, operate and maintain all facilities pertinent to the rendition of water service to a customer's property line. Service will be rendered according to the Service Rules and Regulations of Thaxton Hills Utilities, LLC, the appropriate Rate Schedule, and any Special Agreements which have the proper approval of regulatory authorities.
