MOTION TO INTERVENE OF NEWTON COUNTY MISSISSIPPI

Newton County is a public entity, subdivision of the State of Mississippi, that is located in Mississippi within the service area of Mississippi Power in Central Mississippi. The principal address of Newton County is PO Box 85, Decatur, MS 39327, with offices and facilities throughout Newton County.

On March 15, 2021 Mississippi Power Company ("MPC") submitted its NOTICE OF MISSISSIPPI POWER COMPANY OF ITS 2021 PEP EVALUATION REPORT PURSUANT TO COMPANY'S PERFORMANCE EVALUATION PLAN, which by the testimony provided impacts customer rates.

Newton County as a rate payor, representatives of the County, will see substantial effects from this filing and other related rate actions. The proposed will have an impact on the economy of Newton County, Central Mississippi and MPC's customers.

Newton County has a substantial interest in rate increases and the resulting rates. Therefore, Newton County requests that the Commission approve an order allowing it to intervene.




