Rankin County is a public entity, subdivision of the State of Mississippi, that is located in Mississippi within the service area of Entergy Mississippi, LLC. The principal address of Rankin County is 211 E. Government St., Brandon MS 39042, with offices and facilities throughout Rankin County.

There is now pending before the Commission this audit of Entergy Mississippi including filings under the above reference docket number, on August 3, 2021, the Commission entered an Order implementing recommendation of an independent auditor, and also withholding orders on five (5) other recommendations, and deferred action pending 2021 Fuel Audits. It is anticipated that further audit reports and orders in this matter may impact rate payors.

Rankin County as a rate payor, and representatives of the County and its residents, will see substantial effects from these filing and other related rate actions. The proposed filings will have an impact on the economy of Rankin County, it's residents and upon Entergy customers.

Rankin County has a substantial interest in rate increases and the resulting rates, as well as general transparency in government and the protection of greater public interest. Therefore, Rankin County requests that the Commission approve an order allowing it to intervene.
