By Commission order issued in Docket No. 2020-UA-144, Great River Water is required to file with the Commission "evidence of closing" the sale and transfers approved therein. This letter will confirm the following transactions:

On August 19, 2021, the sale of the Pecan Village sewer system between Great River Utility Operating Company, LLC and Pecan Village, LLC was closed. Operation over the system has now been transferred to Great River Water.

On August 24, 2021 the sale of the Business Park and The Trace sewer systems between Great River Utility Operating Company, LLC and S2 Environmental, LLC were closed. Operations over the systems have now been transferred to Great River Water.

On August 25, 2021 the sale of the Leland Pointe sewer system between Great River Utility Operating Company, LLC and Affordable Homes of Vicksburg, Inc. was closed. Operation over the system has now been transferred to Great River Water.

On August 25, 2021, the sale of the Piney Woods sewer system between Great River Utility Operating Company, LLC and West Coast Lumber, Inc. was closed. Operation over the system has now been transferred to Great River Water.

On September 2, 2021, the sale of the Cedar Lane sewer system between Great River Utility Operating Company, LLC and Cedar Creek Development Inc. was closed. Operation over the system has now been transferred to Great River Water.
