CHEVRON PRODUCTS COMPANY'S MOTION TO INTERVENE

Chevron Products Company, a division of Chevron U.S.A. Inc. ("Chevron"), by and through counsel, files this Motion to Intervene pursuant to Public Utilities Rule of Practice and Procedure 6.121, and in support, would show the following:

- 1. Chevron is a Pennsylvania corporation authorized to do business in the State of Mississippi. Chevron's physical business address in Mississippi is 250 Industrial Road, Pascagoula, MS 39581-3201. Its mailing address is P.O. Box 1300, Pascagoula, MS 39568-1300.
- 2. On May 15, 2015, Mississippi Power Company ("MPC") filed an electric utility rate case with the Mississippi Public Service Commission ("MPSC"), presenting the MPSC with three alternative rate proposals intended to govern MPC's recovery of costs related to its ongoing project in Kemper County, Mississippi. On July 10, 2015, MPC submitted its First Supplemental Filing, proposing a fourth alternative rate.
- 3. Chevron operates a petroleum refinery in Pascagoula, Mississippi, which refines crude oil into gasoline and other usable oil products. The Pascagoula refinery has a longstanding, mutually beneficial relationship with MPC as one of MPC's largest industrial customers. Accordingly, Chevron has a substantial interest in the outcome of this proceeding, and the outcome of this proceeding may impair or impede Chevron's ability to protect its

interests. Chevron has an interest in the adoption of a rate plan that most effectively maintains

stable and reasonable rates for MPC customers. Therefore, Chevron requests that the

Commission enter an order allowing it to intervene.

4. In the event the Commission deems Chevron's intervention request a late

intervention, Chevron accepts the record as it stands in this proceeding and does not seek by this

intervention to delay the proceeding or to prejudice the rights of any other party.

A proposed order granting Chevron's motion to intervene is attached as Exhibit 5.
