Dear Ms. Collier:

This is the July 2019 report required by the outstanding orders of the Public Service Commission in the above-referenced matter. On June 25, 2019, the Public Service Commission and Commissioner Brandon Presley held a Status Conference on the pending open case before the Commission. At that meeting, representatives of the Association gave updates on the status of the various tasks that were ordered by the Commission. On July 8, 2019, the Public Service Commission issued its Second Amended Post Hearing Order.

Item 1 on the Second Amended Post Hearing Order noted Punkin Water Association ("PWA") should post its previous month's meeting minutes on its website seven days prior to its next monthly meeting. PWA's July Board meeting took place on July 8, 2019. The June 2019 minutes were posted on PWA's webpage on July 1, 2019. The draft minutes were posted on PWA's website at <http://punkinwater.com/draft-minutes/>. A link to the minutes was also posted on PWA's Facebook page. A screenshot of that posting is below.

Item 3 on the Second Amended Post Hearing Order required PWA to request a representative from its CPA firm to attend a Board meeting to brief its members on the processes of PWA's financial audit. Kaytee Warren from the Dwight L. Young Group attended PWA's July 8, 2019, Board Meeting and answered questions regarding PWA's financial audit process. 
