IN RE: NOTICE OF INTENT OF ENTERGY MISSISSIPPI, LLC FOR RECOVERY OF
VEGETATION MANAGEMENT OPERATION AND MAINTENANCE COSTS

ORDER

COMING THIS DAY to be considered Entergy Mississippi, LLC's ("Entergy Mississippi" or the "Company") February 1, 2021, submittal ("Annual Submittal") of the Company's Vegetation Management Cost Adjustment Factors, under the Company's Vegetation Management Rider Schedule VM-1 ("Schedule VM-1"). This Commission, being fully advised in the premises, and upon the recommendation of the Mississippi Public Utilities Staff (the "Public Utilities Staff" or the "Staff"), finds as follows:

1. Schedule VM-1 states that the Company will provide Vegetation Management Cost Adjustment Factors on or before February 1st of each year, which reflect the redetermined Vegetation Management Costs for the calendar year immediately following the submission, together with a true-up adjustment reflecting any over-recovery or under-recovery of costs and revenues as of December 31 immediately preceding the submission.

2. Pursuant to the provisions of Schedule VM-1, the Public Utilities Staff has carried out a review of the Annual Submittal, together with a review of Company non-confidential and confidential workpapers supporting the data and calculations reflected and set out therein. The Staff has propounded data requests to the Company, has received responses thereto, and has reviewed the Company's books and records in connection with the Annual Submittal. The Staff

additionally has had the benefit of data and information supplied to the Staff by the Company throughout the year on an ongoing basis.

3. The Commission hereby finds that the data, documentation, exhibits, and other materials submitted in connection with the Annual Submittal and otherwise in this matter comply with the applicable requirements of law and the rules, regulations, and orders of the Commission and with the requirements of Schedule VM-1, and that there is sufficient evidence before the Commission to support the provisions of this Order.

IT IS, THEREFORE, ORDERED, that the Vegetation Management Cost Adjustment Factors under Schedule VM-1 that were submitted by the Company on February 1, 2021, and that are included in Attachment A to this Order, are hereby approved to be in effect for bills rendered on and after the first practicable billing cycle after issuance of this Order and until subsequently changed by order of this Commission.

This Order shall be deemed issued on the day it is served upon the parties herein by the Executive Secretary of this Commission who shall note the service date in the file of this Docket.
