<u>ORDER</u>

THIS CAUSE came on for consideration before the Mississippi Public Service Commission ("Commission") on the filing by Mississippi Power Company ("Company") of its calculation of the Ad Valorem Tax Adjustment Factor for April 2021 through March 2022 (the "Factor") pursuant to its Ad Valorem Tax Adjustment Clause, Schedule "ATA-2" (the "Schedule") as approved by this Commission in Docket No. 1989-UN-5431. The Commission, being fully apprised in the premises and having considered the documents and record before it, and upon recommendation of the Public Utilities Staff ("Staff"), finds as follows:

- 1. On or about February 12, 2021, the Company filed its Notice of 2021 ATA Filing setting forth the calculation of the Factor. This Commission finds that the Company calculated and filed the Factor in compliance with the Schedule and the orders of this Commission. Therefore, we hereby find the 2021 ATA Factor equal to \$0.009409/kWh is just and reasonable and in the public interest.
- 2. This Commission also finds that the Company has reasonably complied with the applicable filing requirements and has provided information sufficient for this Commission's and the Staff's consideration of this matter. Therefore, for good cause shown, this Commission waives any other filing requirements as prescribed by this Commission's Rules and not provided by the Company.
