# PETITION FOR CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

COMES NOW Entergy Mississippi, LLC ("Entergy Mississippi," "EML," or the "Company"), in its continuing effort to make reliability improvements to and modernize its transmission and distribution infrastructure to continue providing safe, reliable, and reasonably priced electric service to its customers, and respectfully files this Petition for Certificate of Public Convenience and Necessity ("Petition") with the Mississippi Public Service Commission (the "Commission") pursuant to Miss. Code Ann. § 77-3-1 et. seq., as amended (the "Mississippi Public Utilities Act" or the "Act"), and RP 7.102 of the Commission's Public Utilities Rules of Practice and Procedure ("Procedural Rules") for a Certificate of Public Convenience and Necessity ("Certificate" or "CCN") seeking authorization from the Commission for Entergy Mississippi to acquire, construct, expand, own, operate, and maintain a new 115/13.8 kilovolt ("kV") substation near Southaven, Mississippi (the "Proposed Snowden Park Substation"), 115 kV transmission lines (the "Proposed Transmission Lines"), and 13.8 kV distribution lines operated at 12.47 kV (the "Proposed Distribution Lines") and other related facilities, rights-of-way, and the related substation terminal facilities and other related equipment and facilities (all of the foregoing being referred to herein after as the "Proposed Electrical Facilities"), all within the certificated public

utility service area of the Company in Desoto County, Mississippi. As grounds for this Petition, Entergy Mississippi would show the Commission the following:

- 1. The Proposed Electrical Facilities are needed to enhance the electrical supply and service reliability for existing commercial and residential customers in DeSoto County, Mississippi, and to serve existing and expected load growth along the Getwell Road corridor in Southaven. In recent years, the Southaven area of Desoto County in EML's service territory has experienced residential and commercial growth that has resulted in increased demand for electric service in that area. As expected, the completion of I-69 through DeSoto County has led to further residential and commercial development, and with it, the demand for electrical service in that area. EML anticipates an increasing need for electrical supply in the Southaven area that would be served by the Proposed Electrical Facilities, including the development of a large-scale commercial and residential development in the east Southaven area. To accommodate this existing and projected load growth, Entergy Mississippi is proposing to build the Proposed Electrical Facilities, which are expected to provide greater operational flexibility and increased reliability for the distribution facilities in Desoto County and to reduce the likelihood of customer interruptions during unplanned outage events.
- 2. The Proposed Electrical Facilities are needed for Entergy Mississippi to continue to meet its obligation to provide safe, reliable, and reasonably priced electric service to its customers in this fast-growing area of DeSoto County. Without the construction of the Proposed Electrical Facilities, increased electrical demand resulting from expected load growth in the east Southaven area along the Getwell Road corridor could result in overloads and voltage collapse on the circuits serving almost 4,500 residential customers in the area, which would adversely affect reliability for those customers.

- 3. The Proposed Electrical Facilities will provide load serving capability to help facilitate further development of residential, commercial, or industrial growth that is anticipated in the Southaven area. Specifically, the Proposed Electrical Facilities will provide additional capacity to serve Getwell Road corridor and eliminate the existing load at risk for customers in that area. In addition, the Proposed Electrical Facilities are expected to provide additional capacity for future load growth along the Getwell Road corridor, thus improving the overall reliability for customers in the area. The Proposed Electrical Facilities were identified as a solution to the identified potential transmission system limitations in the Midcontinent Independent System Operator, Inc. ("MISO") Transmission Expansion Plan ("MTEP"). The Proposed Electrical Facilities were included in Appendix 'A' of MTEP 18 and subsequently approved by the MISO Board of Directors in December 2018.
- 4. After careful review and an alternative route analysis that included an environmental assessment, routes were designed to have minimal impact on the community and environment while balancing costs to customers.
- 5. The Company is requesting that the Commission grant Entergy Mississippi a CCN to acquire, construct, expand, own, operate, and maintain the Proposed Electrical Facilities, including the following:
  - Constructing a new 115/13.8 kV Substation along the Getwell Road corridor;
  - Installing two 115 kV breakers;
  - Installing two 40 mega volt-ampre ("MVA") 115/13.8 kV transformers;
  - Installing two 13.8 kV main breakers;
  - Installing eight 13.8 kV feeder breakers;
  - Installing one 13.8 kV bus-tie breaker;

- Constructing approximately 1.72 miles of new 115 kV transmission lines in new shared right-of-way ("ROW") 120 feet wide to cut into EML's existing Greenbrook-Plum Point 115 kV line;
- Establishing fiber communications to the Proposed Snowden Park Substation;
- Installing approximately 2.14 miles of fiber from Plum Point 115 kV substation to cut-in location and approximately 1.0 miles of fiber from Greenbrook 115 kV substation to the cut-in location;
- Constructing five new distribution feeders totaling approximately 7.7 miles of new overhead and underground distribution;
- Rebuilding approximately 3.8 miles of existing distribution line; and
- Installing new field ties, load transfer equipment and distribution capacitor banks.
- 6. Attached hereto as <u>ATTACHMENT A</u> and made a part hereof is the Direct Testimony of Christopher A. Cooper, Manager of Distribution Asset Planning for Entergy Services, LLC<sup>1</sup> ("ESL"), describing the need for the Proposed Electrical Facilities, and how the Proposed Electrical Facilities were selected as the best solution to enhance reliability and support increasing load growth in the Southaven area of DeSoto County, Mississippi. Attached hereto as <u>ATTACHMENT B</u> and made a part hereof is the Direct Testimony of J. Christopher Jones, Senior Project Manager of Project Management and Construction for Entergy Services, LLC, describing the cost of the Proposed Electrical Facilities and providing an overview of the management of the project. Attached hereto as <u>ATTACHMENT C</u> and made a part hereof is the Direct Testimony of

Anastacia Santos, Project Manager with POWER Engineers, Inc. ("POWER")<sup>2</sup>, describing the methodology and selection of the preferred and alternative transmission line routes, the environmental effects of the Proposed Electrical Facilities, and the results of the environmental analyses of the project. POWER prepared the *Snowden Park 115 kV Transmission Line-Environmental Assessment and Alternative Route Analysis* (the "Alternative Route Analysis") for the Proposed Electrical Facilities. The Alternative Route Analysis is attached to the Direct Testimony of Ms. Anastacia Santos as EXHIBIT AS-2.

- 7. The total cost of the Proposed Electrical Facilities is estimated to be \$37 million, as set out in confidential EXHIBIT JCJ-5<sup>3</sup> to the Direct Testimony of J. Christopher Jones. Subject to the receipt of necessary permits and required approvals, the Proposed Electrical Facilities are currently planned with an in-service date of June 2023.
- 8. New right-of way of approximately 120 feet in width will be required for the approximately 0.86 miles of proposed new transmission line.
- 9. All labor, materials, property, and services to be rendered for the Proposed Electrical Facilities will be supplied at competitive and reasonable prices.
- 10. There are presently on file with this Commission the financial statements of the Company that establish that the Company is financially able to complete the construction described and set out in this Petition.
- 11. The Company is an electric public utility as defined in Miss. Code Ann. § 77-3-3(d)(i).

If not a corporation, the names and addresses of all owners or partners.) A copy of the names and addresses of its boards of directors, officers and any person owning fifteen percent (15%) or more of its stock is on file in Commission Docket 2018-UA-267 and incorporated by reference herein.

The Proposed Electrical Facilities will be part of those Company facilities necessary and useful to the Company's electric utility operations.

General design details for the Proposed Electrical Facilities are attached to the Direct Testimony of J. Christopher Jones as confidential EXHIBIT JCJ-2<sup>4</sup> and EXHIBIT JCJ-3.
- h. (Appendix "A," Schedule 3, Item 8 An estimate of the impact of the cost of facilities upon rate base and rates. This item shall not apply to public utilities excluded from rate regulation pursuant to Miss. Code Ann. § 77-3-1 or § 77-3-5 or to public utilities heretofore or hereafter exempt by Commission order from rate base regulation or to public utilities whose rates are allowed, by Commission order, to be filed for informational purposes only.) The costs of the Proposed Electrical Facilities will be reflected in the Company's rates through the operation of

Entergy Mississippi's Formula Rate Plan and through Commission order. However, the Company currently estimates that the revenue requirement associated with the Proposed Electrical Facilities would result in an approximately \$0.32 impact on a monthly bill of a typical residential customer using 1,000 kWh, assuming that the project is timely reflected in a FRP Rate Adjustment.

- i. (Appendix "A," Schedule 3, Item 9 An exhibit listing the names and addresses of all interested persons as defined in RP 2.115 of the Commission's Procedural Rules together with a certificate that the filing utility has served a notice of the filing upon each.) - 13. Pursuant to Procedural Rule RP 1.102, the Company hereby moves for and requests a waiver of and permission for deviation from part of the requirements of Appendix "A," Schedule 3, Item 7, of the Procedural Rules to allow the Company not to file with this Petition any required health and environmental approvals or a complete set of plans and specifications for the facilities proposed herein, but rather to make such health and environmental approvals and a complete set of plans available, upon request, to the Mississippi Public Utilities Staff ("Public Utilities Staff") when such plans and specifications are completed and thereby available. Confidential <u>EXHIBIT JCJ-2</u> and <u>EXHIBIT JCJ-3</u> to the Direct Testimony of J. Christopher Jones show general design details of the Proposed Electrical Facilities. Requiring health and environmental permits and

complete plans and specifications to be filed with this Petition would be unduly burdensome and impractical since they do not yet exist, and such requirement also would be unnecessary because the health and environmental permits and complete plans and specifications will be available for Public Utilities Staff review when they are completed.

- 14. To the extent, if any, that this filing does not meet all of the technical requirements of the Commission's rules, the Company hereby respectfully moves and requests, pursuant to RP 1.102, that the noncompliance be waived by the Commission.
- 15. Subject to the receipt of necessary regulatory approvals, Entergy Mississippi is ready, willing, and able to acquire, construct, expand, own, operate, and maintain the Proposed Electrical Facilities that are the subject of this Petition. The public convenience and necessity require and will require the issuance by the Commission of a Certificate of Public Convenience and Necessity authorizing the acquisition, construction, expansion, ownership, operation, and maintenance of the Proposed Electrical Facilities.

The Company further prays that the Commission shall approve the estimated costs of the

Proposed Electrical Facilities and shall grant unto the Company a certificate that the public

convenience and necessity require and will require the acquisition, construction, expansion,

ownership, operation, and maintenance of the Proposed Electrical Facilities in Desoto County,

within the State of Mississippi, and as particularly described, set out, and applied for herein, and

shall grant all approvals necessary for the Company to complete the projects described herein.

The Company prays for such other, further, and general relief as may be required, needed

or beneficial.
