ORDER

COMES NOW, the Mississippi Public Service Commission (the "Commission"), *sua sponte*, and issues this Order following the submission of Midcontinent Independent System Operator, Inc.'s ("MISO") comments and responses to the requests made by the Commission in its October 27, 2021 Order, as follows:

- 1. On April 6, 2021, the Commission issued an order establishing this docket to investigate the long-term benefits, costs, and commitments of Entergy Mississippi, LLC's ("EML") membership in MISO. By way of its Order Establishing Docket, the Commission sought comments on certain topics.
- 2. Since the issuance of the Commission's Order Establishing Docket, there have been several developments in the MISO stakeholder process that have the potential to materially impact the cost and benefit of EML's continued membership in MISO. Accordingly, the Commission issued an order requesting additional comments and responses from MISO on October 27, 2021.
- 3. On November 24, 2021, MISO submitted comments and responses to the requests made by the Commission in its October 27, 2021 Order. After due consideration, the Commission finds that MISO's comments and responses contain certain deficiencies that the Commission will address by way of data requests to MISO.
- 4. After the Commission has received and evaluated MISO's responses to its data requests, the Executive Secretary of the Commission shall issue a subsequent Order outlining future filing deadlines for parties in this docket.

5. The Executive Secretary of the Commission is instructed to serve a copy of this Order on MISO, EML, and on all other parties intervened in this docket.

This Order shall be deemed issued on the day it is served upon the parties in this docket by the Executive Secretary of this Commission who shall note the service date in the file of this docket.
