ORDER STAYING TARIFF PROVISIONS

COMES NOW, the Mississippi Public Service Commission (“Commission”), on its own motion, and issues the following Order in the above-captioned dockets:

PROCEDURAL HISTORY

1. On January 12, 2021, the Commission established Docket No. 2021-AD-19, “for the purpose of reviewing the efficacy and fairness of the Mississippi Renewable Energy Net Metering Rule and the Mississippi Distributed Generator Interconnection Rule.” At the conclusion of the Commission’s rulemaking proceeding, Entergy Mississippi, LLC (“EML”) and Mississippi Power Company (“MPC”) were ordered to make tariff filings establishing three Commission-mandated

programs: (1) Public K-12 Solar for Schools; (2) Low-to-Moderate Income Energy Independence Incentive; and (3) Residential Demand Response Battery Incentive. EML and MPC complied with the Commission's Order and made the appropriate filings in the above-styled dockets; EML and MPC's rate notice filings were later approved by the Commission.

2. When the Order was entered in 2022, the Commission found that the three programs represented "a significant economic incentive that will effectively bolster and entice distributed energy adoption for low-income customers of the rate-regulated electric IOUs in the state" and that "access to renewable energy for public schools was in the public interest."

3. Following the Commission's Final Order in Docket No. 2021-AD-19, the United States Environmental Protection Agency, released the \$7 billion Solar For All Notice of Funding Opportunity, which will award up to 60 grants to states, territories, Tribal governments, municipalities, and nonprofits to expand the number of low-income and disadvantaged communities primed for residential solar investment—enabling millions of low-income households to access affordable, resilient, and clean solar energy. The Commission is aware that the State of Mississippi, through the Mississippi Development Authority, submitted an application requesting funding to increase residential rooftop solar deployment in the state.

COMMISSION FINDINGS

4. Due to the availability of federal funds available to increase residential rooftop solar deployment in Mississippi, as well as other funds available through Federal Agencies, the Commission finds that EML and MPC's, Low-to-Moderate Income Energy Independence Incentive, and Residential Demand Response Battery Incentive tariffs should be stayed pending further evaluation by the Commission. The Commission finds that staying the tariff provisions

associated with above-mentioned programs is in the public interest, as it will allow the Commission to monitor adoption of distributed energy resources in the state without ratepayer funded incentives.

IT IS THEREFORE ORDERED that EML's Solar for Schools Rate Schedule SFS-1, Section IV of EML's Net Energy Metering Rate Schedule NEM-2, MPC's Solar for Schools Rate Schedule SFS, and MPC's Low-to-Moderate Incentive Program and Battery Storage Incentive Program RENM-1 are hereby STAYED pending further evaluation by the Commission.

IT IS FURTHER ORDERED that the EML and MPC's Low-to-Moderate Income Energy Independence Rebates and the Residential Demand Response Battery Rebates are hereby SUSPENDED pending further evaluation by the Commission.

IT IS FURTHER ORDERED that the EML and MPC's Solar for Schools tariffs are hereby SUSPENDED pending further evaluation by the Commission.
